## Code of Conduct

1. Participants are required to be a registered member of the Boys & Girls Club of Victoria.
2. The Club phone is for business and employees only. A member may use the phone to call to be picked up (two minuet limit). Cell phones are not allowed.
3. No alcoholic beverages or tobacco products of any kind are allowed on the premises.
4. Weapons of any kind will result in immediate dismissal. And turned over to local police department.
5. Horseplay will not be allowed. If a fight occurs, both individuals will be removed for the day. Upon review, individuals involved may be expelled for the duration.
6. No foul language will be tolerated.
7. Members that follows rules, participate in events, do not cause problems and attend Regularly will be eligible for field trips.

## Dress Code

1. Do-rages are not permitted; Boys cannot wear caps inside the facility.
2. Boys are not allowed to wear pants below their waistlines or earrings
3. Girls are not allowed to wear suggestive clothing or show body piercing.
4. Facial piercing jewelry cannot be worn in the facility or on field trips.
